SHAKE WELL BEFORE USING

Application rates of **Alligare Super Marking Dye** will differ depending on conditions, tank mix partners, spray application rates and other conditions. To find the best rate of application, vary the rate of **Alligare Super Marking Dye** to find a rate that is cost-effective, yet is visible for the desired length of time. Users and applicator should start at the low use rate and increase the amount of **Alligare Super Marking Dye** until the desired effect is achieved.

USE RATES

4 to 12 ounces per 100 gallons of spray solution. For smaller spray applications using backpacks and small sprayers, use 1/3 to 2/3 ounce, (approximately 2 to 4 tsp.) per three gallon tank.

STORAGE

Store in a cool, dry place in the original container only. Keep container closed until ready to use. Do not allow water to be introduced into the product in this container. Do not store near heat or open flame. Do not store with oxidizing agents or ammonium nitrate.

DISPOSAL
